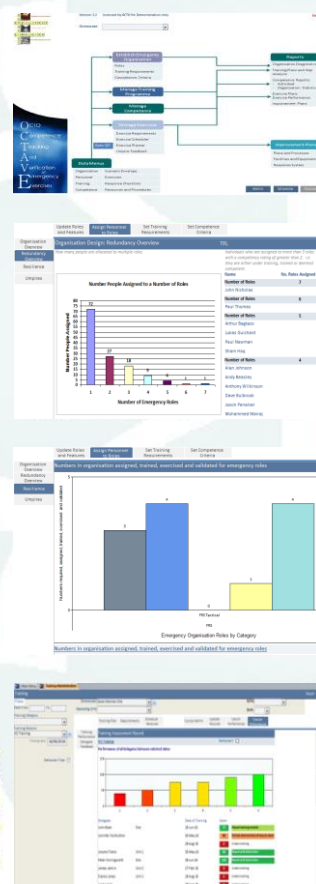

In every organisation, the work of planning and delivering emergency arrangements can be time consuming and costly. Making the best use of management time, capitalising on lessons learned, and demonstrating to regulators the planning and depth of your training and exercising can be a headache.

Establish Organisation

Define your emergency organisation:

- Define requirements for all emergency roles

is a streamlined version of the full **OCTAVE** programme.

It is designed for users whose primary requirement is administration of Emergency Organisation and Emergency Exercises.

Manage Exercise Regime

Co-ordinates all exercise records: exercises; organisation; people; resources; procedures; scenarios:

- Schedule emergency exercises
- Organise exercise planning meetings
- Exemption reporting for personnel, procedures, resources and scenarios
- Plan an exercise in detail
- Comprehensive exercise reporting

Resources & Procedures

Maintain accurate and auditable records of resources and procedures:

- Define key resources and procedures
- Define performance standards
- Build into exercise regime and track performance
- Defines and manages improvement plans arising out of exercise performance

Improvement Plans

Track improvement with **OCTAVE** built-in improvement plan

- Define improvements arising from performance in exercises
- Display improvement plans and monitor progress
- Print out management reports

Demonstrate compliance across whole organisation

An important element of delivering a complex emergency management system is the ability to demonstrate its effectiveness to a regulator. Although records are generally available, they are frequently found in diverse systems and require considerable cost in time and effort to collate when the 'inspector calls'.
